
Executive Summary



Key Messages

- UIG update meetings have been moved to a twice weekly basis on Monday and Thursday each week until late January 2018.
- DESC meeting on 11th December 2017 was cancelled, however, the algorithm performance evaluation results were published on the joint office website. This included the expanded sample dataset. The meeting has been re-arranged for 19th December where the analysis will be discussed.

DM Read Rejections	All pot 1 DM read rejections have now been resolved with consumption adjustments being input where asset queries still exist. Consumption adjustments are being input for 18 meter points at present for pot 1. Within pot 2, there are currently 22 queries open, 15 of which are contributing to UIG and 7 are having consumption adjustments input.
Erroneous AQs	Enduring fix for erroneous AQ's was completed successfully on 8 th December 2017. Monthly Rolling AQ process has been successfully executed for December.
CSEP / LDZ Mapping	iGT's continue to cleanse their own data. Based on the information we have received from GT's to date, we do not believe that there are large volumes of CSEPS that have been identified within the incorrect LDZ.
Analyse cause of volatility	There is an expectation that early visibility of two urgent UNC modifications will be issued by Joint Office week commencing 18 th December 2017.


