# **Section C: DSG Discussion**

## C1: Delivery Sub-Group (DSG) Recommendations

DSG Date:	27/04/2020
	SH presented this agenda item. SH stated that the CDSP has received a number of urgent change proposals that relate to COVID-19.  XRN5161 is looking to amend the frequency of the UIG additional national data form monthly to weekly. That data is loaded to secure area of Xoserve.com for Shippers to get the appropriate data. Due to this being classed as a fast track due to COIVD-19 this meeting is the first DSG it is being presented at, this is due to ChMC having been informed of the Change approving for this to be taken to DSG for ratification.
DSG Summary:	Furthermore, SH stated that ChMC have been informed of the XRN and given approval for this to progress into capture. This will go to the next ChMC for formal approval into delivery and to agree funding. In addition, 3 solution options are being proposed:  1. Replace existing monthly data load file with a weekly file  — This solution is looking to stop producing the monthly file but to start loading instead, a single file every 7 days, containing the same information but just 7 gas days' worth of information.  2. Keep the existing monthly data load file and update it weekly  — This solution is looking to keep the monthly file but add data to it every 7 days until the monthly file has been completed (with a new file being created for the following month). This monthly file will be version controlled to show the additions of data.  3. Keep the existing monthly data load file but also introduce a weekly (7 day) version  — This solution is looking to keep the existing monthly file but to also start producing a weekly view (to be placed in a separate folder) that is to be produced every 7 days.
	SH stated that the steer from the proposer and CDSP is solution option 2. DSG were asked for their preference and steer on the options mentioned.  DSG indicated that this would need to be reviewed within their organisations. PO asked DSG to go back to their organisations and review the slides to provide a more detailed view on what their preferred options are and to get in touch with SH in regard to the preference and reasoning.



	Following DSG a number of members have contacted the CDSP with regards to giving their support of Solution Option 2 outlined above as the preferred option to be delivered.
