This role plays a pivotal part in the development of a holistic view of the organisations architectural landscape, requiring alignment with and support of the other architectural disciplines within the team.

- Development and implementation of data architecture frameworks.
- Governance of Data Architecture artefacts (TOGAF).
- Represent all aspects of Data Architecture within the Architecture Review Board.
- Strategic alignment of a scalable and efficient data ecosystem to meet current and future needs.
- Establishment of a data governance framework with developed policies for data quality, security and lifecycle management, ensuring regulatory and industry compliance.
