Sustain Plus Programme Progress Overview



95% of development and 80% of functional UAT complete



More than 250 users have indicated they will participate in Market Trials



Work on production readiness and API's continues to plan



System Integration Testing and End to End business scenario Testing is in progress



Additional Regression testing planned ahead of Market Trials



Detailed implementation dress rehearsals and cutover planning has progressed

Timeline

- Previously we communicated our intent to commence Market Trials in 2 phases:
 - APIs from 3 June to 17 July
 - Various business processes/screens from 17 June to 17 July
- We have continually reviewed our timelines to ensure that the benefit of the Market Trials phase is maximised for our customers. Now, at this point in the programme, to be better prepared, and provide an enhanced experience for our participants, we will move the business process / screens dates closer to implementation. Moving the API dates will allow our customers to ensure that they have sufficient time to complete preparation activities, having taken into consideration the delay in issuing credentials.
- In conclusion, we are proposing the following amended dates for Market Trials
 - APIs from 17 June to 12 July 2024
 - Business processes/screens from 5 August to 30 August (note APIs can also be tested)

Please note there is no change to the planned implementation date of 8 **September 2024 or** contingency date of 22 September 2024 (and associated outage timings).

What to expect:

- Credentials will be shared
 - Client ID
 - Client Secret
 - Subscription Key
 - Resource
 - 56 plus 2 new API endpoint URLs for Market Trials will be shared week commencing 20 May 2024

Next steps:

- Shippers will generate the JSON Web Token using the shared credentials
- Test API client\tool to be set up to access new APIs
- New APIs will be accessible for testing from mid-June

For information:

- All previously available APIs (56) will be available as well as 2 new ones as mentioned above will be shared
- All APIs are accessed via internet only and can support both JSON and XML

Historical Access to Gemini

- Access to Gemini has historically been via IX and Citrix
- This has proved costly to operate
- Resulted in a high barrier to entry
- Support for limited range of devices
- Complicated IT infrastructure required to access

Access to Gemini Sustain Plus

- Gemini Sustain Plus will be available over public Internet
- Lower cost and low barrier to entry for new industry participants
- Will enable more flexible working
- Easier disaster recovery and Business Continuity
- New security: need to replace closed network and Citrix with new security to ensure continued security
- Secure browser sessions using 'TLS' security
- Secure log-ons: to ensure that log-ons are secure
 - Multi-factor Authentication (MFA) using Microsoft Authenticator does this
 - Runs on Android or iOS
 - No mobile phone restrictions required
 - Supports the use of biometric identification on mobile phone (e.g. FaceID on iPhones)
- Data in Gemini Sustain Plus exposes Shippers and Traders to financial risk
- Data in Gemini Sustain Plus used by National Gas to ensure that the GB gas network is balanced and that there is security of supply
