APIs

- Please check the webpage Gemini Sustain Plus (xoserve.com), for the latest versions of documents, currently version 0.2 and updated FAQs
- Data is up to January 2024 in the test environment
- When connecting to the Market Trials APIs please note that the login process requires
 redirection to be enabled on the API Client (to allow connection to Microsoft EntraID) –
 if this is not enabled then you will receive a HTTP 3XX error message.
- Please note you need to use the new test URL and your new credentials to access

FAQ

Process to access the Login API in MKT URL: https://test.geminiplus.co.uk/api-login

Below details needs to passed in the Body with content-Type as application/x-www-form-urlencoded:

- grant_type: client_credentials
- client_id: {{client_id}}
- client_secret: {{client-pass}}
- resource: 7e6600cc-1039-4161-94da-aa29a5687416

Notes

User will need to pass client_credentails as grant_type
User will need to provide their client_id and client_secret which was provided in earlier communication
User will needs to enable the redirect if they are not able to access the above URL directly.
User will need to pass the details in body and not in the header
