
Overall Programme RAG status is **Green**. During the winter period the programme will focus on Product Refinement and implementation readiness activities.

- **Gemini Sustain Plus Focus Group** The next focus group will be hosted **20**th **January 2025**. The Focus Groups will provide valuable insight into operational and technical developments within the programme including demonstrations of screen changes and improvements. We will be focusing on providing a de-brief for the next market trial phase, the progress of the programme, training and any key reminders ahead of go-live.
- Onboarding (Online screens) Gemini users will have received an invite from the upgraded Gemini system to onboard to Gemini. These are not phishing emails and may go to your users Junk email folders depending on your organisations email settings. 65% of invited Gemini users have completed onboarding We strongly advise organisations to ask their Gemini users to complete their onboarding so that we can resolve any issues or it will impact your Gemini access.
- Switch to the new API Gateway Azure API credentials will have been shared with your Nominated lead to enable you to switch over to new and live Gemini API gateway. The latest versions of the API specification, URL end points and schema files are available on our dedicated webpage. 60 organisations have switched the API gateway. We strongly encourage organisations to switch to the new API gateway by the end of December 2025 so we can support and help resolve any issues.
- User Agreements We are reviewing all User agreements for Gemini access so that we can ensure the correct access is given for day 1 of Gemini go-live. We will be reaching out to organisations that require user agreements to be put in place ahead the go-live. If this isn't done this will your Gemini users will unable to access all their relevant BA codes.
- Training The Gemini Learning management system will be made available to the wider industry on 23rd January 2025 in preparation for the next Market Trial phase and go-live of the upgraded Gemini.
